

SafetyCloud is Now Issuing Temporary License for Working at Height Training

Aligning ourselves to best practices is part of our business strategy. From 01 June 2023, SafetyCloud will be issuing temporary licenses to those delegates who are deemed competent.

To ensure a seamless learning experience, delegates are asked to provide a valid medical certificate of fitness and a certified copy of his/her ID or passport – in the event that these documents are not provided on the first day of training, delegates will regrettably not be accepted into training.

The practices noted above were taken to align with the procedures set by the IWH and Services SETA.



Before training:

A valid medical certificate of fitness issued by an Occupational Health Practitioner and certified ID or passport copy will be requested – failure to provide documentation on the first day of training, the delegate(s) will not be allowed in training



After training:

SafetyCloud will issue a Temporary License to Operate, as most delegates require documentation for working

A temporary license is issued to delegates if found competent.

A temporary license will be made available to delegates within 20 working days after course completion. See appendix A, on page 2

A temporary license is only valid for a period of three months from the date of issue.

The delegate will then be registered with the IWH and will await their IWH license, Statement of Results (SOR) from Services SETA and a SafetyCloud certificate indicating competency against the unit standard. See appendix B, on page 3.

The practices noted above applies to public and inhouse/on-site working at height training.
